P.L. 93-638 contract with the Bureau of Indian Affairs; and

WHEREAS, Child Welfare Services caseload has increased tremendously and there has not been enough funding to meet these needs; and

WHEREAS, Project 2000 is a 5 year phase plan to increase funding for additional staff to address the increased need for child welfare services; and

WHEREAS, in reviews, both Executive and the Legislative Oversight Committees recommend approval of Phase 1 budget and will address each phase annually as funds are available.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative

Council does hereby approve the Tohono O'odham Nation Base

Budget for Family and Children's Services - Project 2000 Phase I in
the amount of \$63,923.00 for 6 months until the end of FY 1996.
