RESOLUTION NO. 96-165

WHEREAS, the Tohono O'odham Nation is presently operating the Community Health Representative/Community Health Services Program under FY 1996 P.L. 93-638 Master Health Contract with the Indian Health Services; and

WHEREAS, any amendments affecting the funding or funding levels of the contract shall be submitted for review and approval by the Tohono O'odham Legislative Council; and

WHEREAS, an amendment has been submitted for review and approval by the Community Health Representative/Community Health Services Program.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby approve and request Indian Health Services to modify the Master Health Contract No. 249-96-0001 to incorporate the attached budget.

BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation's officials, to wit: the Chairman and Vice

Chairman and any designated official are hereby authorized to negotiate and execute the contract, provided however, that any amendments affecting the funding or funding levels of this contract shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Council on the 12TH day of APRIL, 1996 at a meeting at which a quorum was present with a vote 1,457.0 FOR; -0- AGAINST; -0- NOT VOTING; and 419.0 [06] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1 (f) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
