20 with Section 4 of Article III of the **Enrollment Ordinance**; and place

24 **Tohono O'odham Nation** in accordance with Article V of the

23 The foregoing Resolution was passed by the **Tohono O'Odham Council** on the
24 **06TH.** day of **MAY, 1996** at a meeting at which a quorum was present with a
25 vote of 1,654.0 **FOR**; -0- **AGAINST**; -0- **NOT VOTING**; and 222.0 [07] **ABSENT**,
26 pursuant to the powers vested in the Council by Section 1 of Article II and
27 Section 1(h) of Article VI of the Constitution of the **Tohono O'Odham Nation**,
28 adopted by the **Tohono O'Odham Nation** on January 18, 1986; and approved by
the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,
1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
