4 **WHEREAS, the Department of Housing and Urban Development guidelines**

6 **require a selection criteria for identifying those families most in need**

8 **of housing who will receive home renovation through the 1996 HOME**
9 **grant program; and**

11 **WHEREAS, the ten (10) Districts participating in the 1996 HOME grant program**
12 **(of the 11 Districts which comprise the Tohono O'odham Nation) has**
13 **defined their selection criteria on the basis of families with elderly**
14 **and/or handicapped members, families who live in seriously**
15 **overcrowded conditions, families living in structurally unstable homes,**
16 **homes in urgent need of repair, homes with no amenities (i.e. indoor**
17 **plumbing, sewage lines), families with very low income not to exceed**
18 **90% of the median income for the area (Pima County, Arizona)**

proposed selected participants and construction projects for the HUD
Indian HOME Grant be therefore adopted for submission to HUD for
funding.**

day of MAY, 1996 at a meeting at which a quorum was present with a vote
1,734.0 FOR; -0- AGAINST; -0- NOT VOTING; and 142.0 [10] ABSENT, pursuant
to the powers vested in the Council by Article VI, Section 1 (c)(2) of the
Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham
Nation on January 18, 1986; and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16
of the Act of June 18, 1934 (48 Stat. 984).**
