

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Amendment No. 1 to the Attorney Contract with the**  
**Law Office of Russell C. Winston)**

**RESOLUTION NO. 96-196**

**WHEREAS, by Resolution 95-524, the Tohono O'odham Legislative Council**  
**approved an Attorney Contract with the Law Offices of Russell C.**  
**Winston to provide legal representation to the Nation in connection**  
**with an adoption proceeding involving an enrolled member of the**  
**Nation pending in Shelby County Tennessee Chancery Court; and**

**WHEREAS, the Attorney Contract is in the amount of \$5,000 for fiscal year 1996;**  
**and**

**WHEREAS, the additional sum of \$1,500 is required for legal fees and expenses**  
**to assure uninterrupted legal representation for fiscal year 1996; and**

**WHEREAS, sufficient funds are available in the budget of the Office of Attorney**  
**General to supplement the Attorney contract by such amount; and**

**WHEREAS, the Domestic Affairs Committee recommends approval of Amendment**  
**No. 1 to the Attorney Contract to increase the Contract amount by**  
**\$1,500.**

**NOW, THEREFORE, BE IT RESOLVED THAT:**

**1. The Tohono O'odham Legislative Council hereby approves**

Amendment No. 1 to the Attorney Contract with the Law Office  
of Russell C. Winston in the form attached hereto, which

year 1996 operating budget of the Office of Attorney General.

2. The Chairman of the Nation is authorized and directed to  
execute Amendment No. 1 to such Contract.

The foregoing Resolution was passed by the Tohono O'Odham Council on the 8TH  
day of MAY, 1996 at a meeting at which a quorum was present with a vote  
1,600.0 FOR; 134.0 AGAINST; -0- NOT VOTING; and 142.0 [09] ABSENT, pursuant  
to the powers vested in the Council by Article VI, Section 2 (a) of the Constitution  
of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on  
January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian  
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
18, 1934 (48 Stat. 984).
