9 **budget would be determined upon the amount of gaming revenue**

13 **WHEREAS, the Schuk Toak District Council by Resolution #ST-04-27-96-07 did**
14 **approve to modify the FY-96 Budget in the amount of \$53,275.08**
15 **utilizing the remaining gaming revenues; and**

17 **WHEREAS, the amount of gaming revenues distributed to Schuk Toak District**
18 **was in the amount of \$520,241.45, with a remaining balance of**
19 **\$80,471.03; and**

22 **WHEREAS, the Schuk Toak District Council by Resolution #ST-04-27-96-08 did**
23 **also approve to invest \$27,195.95 with Paine Webber Inc. utilizing the**
24 **remaining balance of gaming revenues after the modification; and**

modification #1 in the amount of \$53,275.08 and also the amount of \$27,195.95 to be invested utilizing the remaining balance of gaming revenues in the amount of \$80,471.03.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby approve the FY-96 budget modification for Schuk Toak District in the amount of \$53,275.08 to be expended in accordance with the attached budget and also the amount of \$27,195.95 to be invested utilizing the remaining balance of gaming revenues in the amount of \$80,471.03.

The foregoing Resolution was passed by the Tohono O'Odham Council on the 10TH day of MAY, 1996 at a meeting at which a quorum was present with a vote 1,574.0 FOR; -0- AGAINST; -0- NOT VOTING; and 302.0 [11] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1 (d)(3) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
