**WHEREAS, the Baboquivari District formally established a local Plant and  
Wildlife Committee in October 1994; and**

**WHEREAS, the Baboquivari District Plant and Wildlife Committee presented the  
attached Private Lands Agreement to the Baboquivari District Council  
and the District Council did approve the Agreement and Authorize  
the District Chairman and the Plant and Wildlife Committee to  
present the Agreement to the Tohono O'odham Legislative Council;  
and**

**WHEREAS, the Legislative Council's Cultural and Natural Resources Committees  
did review and approve the Private Lands Agreement; and**

**WHEREAS, the Tohono O'odham Legislative Council has reviewed the Private  
Lands Agreement and finds the Agreement to be in the best interest  
of the Nation.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative  
Council approves the attached Private Lands Agreement and  
authorizes the Chairman of the Nation and the Chairman of the  
Baboquivari District to execute the Agreement.**


