**RESOLUTION NO. 96-220**

**WHEREAS, the Tohono O'odham Legislative Council did approve Resolution No.**  
**96-213 (Appropriation of \$30,100 for Proposed Bank Renovation**  
**from FY'96 Capital Equipment Budget) during the May 15, 1996**  
**General Session; and**

**WHEREAS, upon presentation of Resolution No. 96-213 to the Chairman of the**  
**Tohono O'odham Nation, he did disapprove thereof and returned**  
**it to the Council with his objections in accordance with the**  
**provisions of Article VII, Section 5 of the Constitution of the**  
**Tohono O'odham Nation; and**

**WHEREAS, during the June 3, 1996 Legislative Session, the Vice Chairman of**  
**the Nation presented his justifications in vetoing Resolution No.**  
**96-213; and**

**WHEREAS, the Tohono O'odham Legislative Council has reviewed the**  
**Chairman's objections and after consideration again voted to pass**  
**Resolution No. 96-213.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative**  
**Council does hereby override the Chairman's veto of Resolution No.**  
**96-213 by a vote of two-thirds of the votes cast.**




The foregoing Resolution was presented to the Tohono O'Odham Legislative Council on the 3RD day of JUNE, 1996 at a meeting at which a quorum was present with a vote of 1,138.0 FOR; 543.5 AGAINST; 194.5 NOT VOTING; and 03 ABSENT, was passed by majority of at least TWO-THIRDS (2/3) [1,121.0] of the votes cast as required by Section V of Article VII of the Constitution of the Tohono O'Odham Nation.
