22 vote of 1,622.0 FOR; -0- AGAINST; 71.0 NOT VOTING; and 183.0 [07] ABSENT,
23 pursuant to the powers vested in the Council by Section I of Article II and
24 Section I(h) of Article VI of the Constitution of the Tohono O'Odham Nation,
25 adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by
26 the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,
27 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


