3 **WHEREAS, the Legislative Council of the Tohono O'odham Nation hereby**  
4 **authorizes the Chairman of the Nation to execute a contract for**  
5 **rental income and to accept the rental income from Contract services,**  
6 **Inc., on behalf of the Nation; and**

9 **WHEREAS, the rental income is for the use of the concrete batch plant located**  
10 **at the OCM yard; and**

11  
12 **WHEREAS, the rental income is for \$1,000 per month for an estimated five (5)**  
13 **month period; and**

14  
15 **WHEREAS, the rental income shall be applied to the Nation's General Fund**  
16 **Account No. 01-0000-450.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council of the Tohono**  
19 **O'odham Nation does hereby authorize the Chairman to sign a rental**  
20 **contract and accept the rental income.**

22 **BE IT FURTHER RESOLVED that the rental income be deposited to the Nation's**  
23 **General Fund Account No. 01-0000-450.**

26 **The foregoing Resolution was passed by the Tohono O'Odham Council on the 5TH.**  
27 **day of JUNE, 1996 at a meeting at which a quorum was present with a vote**  
28 **1,771.0 FOR; -0- AGAINST; -0- NOT VOTING; and 105.0 [06] ABSENT, pursuant**  
**to the powers vested in the Council by Article VI, Section 1 (d) of the Constitution**
