3 **WHEREAS, the Tohono O'odham Nation Executive and Legislative Council**

5 **recognize the need for improved services to O'odham elderly; and**

6 **WHEREAS, the Tohono O'odham Nation operates a program for the elderly**

8 **members of the Nation; and**

9 **WHEREAS, the Inter-Tribal Council on Aging has approved and granted one time**
10 **only Title III Older American Act funding in the amount of \$9,500;**

12 **and**

13 **WHEREAS, the Senior Services is in need of two new stoves and a refrigerator**

15 **for preparing meals for the elderly; and**

16 **WHEREAS, the one time only funds must be encumbered by June 30, 1996.**

18 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative**

20 **Council that it hereby approves the incorporation of funds into**
21 **Account #13-1422 for Capital Equipment for the purchase of needed**
22 **kitchen appliances.**

24 **BE IT FURTHER RESOLVED that any amendments affecting the funding or**

26 **funding level of this grant shall be submitted for further approval by**
27 **this Council.**


