**WHEREAS, negotiated and modified the annual funding agreement on February  
9, 1996 and identified funds in the amount of \$64,667.00; and**

**WHEREAS, Budget Modification No. 2 has been submitted for review and  
approval by the Psychological Services Program.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council  
that it does hereby approve the modification to the Psychological  
Services Program contract and authorized expenditures in accordance  
with the attached budget.**




