

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Schuk Toak New Farm Predesign/Design FY 1996 Supplemental Budget)**

RESOLUTION NO. 96-256

WHEREAS, the Southern Arizona Water Rights Settlement Act of 1982 (SAWRSA) authorized certain agricultural developments to be designed and constructed through the Bureau of Reclamation ("Reclamation"); and

WHEREAS, the Tohono O'odham Nation agreed to P.L. 93-638 Cooperative Agreement (No. 3-FC-32-00200, Council Resolution No. 93-356) with Reclamation ("Reclamation") to complete the predesign and design for the Schuk Toak New Farm; and

WHEREAS, the Nation incurred certain obligations under SAWRSA relating to subjugation which are now considered part of the predesign/design efforts; and

WHEREAS, the Water Projects Office requests from the Tohono O'odham Nation, supplemental funding for FY 1996 to cover those costs not now funded by Reclamation which are necessary to complete predesign and designs for the Schuk Toak New Farm.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby approve the funding request for FY 1996

8 **BE IT FINALLY RESOLVED** that the Nation shall seek reimbursement of those

9 funds previously advanced by the Nation for costs which are the

11 responsibility of the Secretary of the Interior under SAWRSA.



17 of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on
18 January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian
19 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
20 18, 1934 (48 Stat. 984).
