

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(To Rescind Ordinance No. 25)**

**RESOLUTION NO. 96-272**

**WHEREAS, the Tohono O'odham Legislative Council did on July 09, 1996 enact Resolution No. 96-271 to waive the 3% tax on livestock sales due to low prices and drought conditions on the Nation as presented to the Council by the Chairperson of the Schuk Toak District; and**

**WHEREAS, Resolution No. 109-81, (Ordinance No. 25, Re-enacted and Restated the Livestock Ordinance, which included the 3% Cattle Tax, excluding Sections IV, V, VI, and VII of the Livestock Ordinance; and**

**WHEREAS, the 3% sales tax on the sale of livestock imposed under Ordinance No. 25, effects the prices of livestock sales which has dropped due to the drought condition on the Nation; and**

**WHEREAS, the Tohono O'odham Legislative Council has determined that Ordinance No. 25 be rescinded due to the concerns caused by the drought on the sale of livestock by members of the Nation, Nation's District and Livestock Owners..**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby rescind Ordinance No. 25 as enacted by this said resolution.**

9 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16**  
10 **of the Act of June 18, 1934 (48 Stat. 984).**
