WHEREAS, the Districts requesting financial assistance from the Nation in years past have done so in order to continue meeting the needs of the members of the Nation; and

WHEREAS, it behooves the Nation's Legislative Council to show compassion and magnanimity for the people of the Nation; and

WHEREAS, the Nation's Legislative Council recognizes and respects the service and dedication of the Districts in providing for needs of the people of the Nation.

Declares and affirms that the Districts are not expected to repay 8 the funds provided by the Legislative Council to the Districts (see 9 10 Exhibit A attached), within the past year and for years past, for 11 governmental uses and for meeting the needs of the people. 12 13 That the Legislative Council agrees and directs that funds be 2. 14 returned to those Districts who have repaid, in good faith, 15 16 amounts requested by the Nation's Accounting Department. 17 BE IT FURTHER RESOLVED that the Nation's Chairman is authorized to execute 18 19 such document or documents that may be required to effect this 20 action. 21 22 The foregoing Resolution was passed by the Tohono O'Odham Council on the 9TH. day of JULY, 1996 at a meeting at which a quorum was present with a vote 23 1,171.0 FOR; 705.0 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the 24 powers vested in the Council by Article VI, Section 1 (d)(2) of the Constitution of 25 the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs 26 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934
