**WHEREAS, the Tohono O'odham Nation Scholarship Fund has brought forth the  
Tohono O'odham Nation Scholarship Policy; and**

**WHEREAS, the program does not have a policy set in place to help enforce the  
program's present rules and guidelines; and**

**WHEREAS, the policy will include the rules and guidelines of the program and  
how the program will be administered.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council  
that it does support and recognize the Tohono O'odham Nation  
Scholarship Fund Policy.**

**BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that it  
approves the Tohono O'odham Nation Scholarship Fund's Policy.**

**The foregoing Resolution was passed by the Tohono O'Odham Council on the  
11TH day of JULY, 1996 at a meeting at which a quorum was present with a  
vote 1,106.0 FOR; 583.0 AGAINST; 187.0 NOT VOTING; and [06] ABSENT,  
pursuant to the powers vested in the Council by Article VI, Section 1 (1) of the  
Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham  
Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16  
of the Act of June 18, 1934 (48 Stat. 984).**
