BE IT FINALLY RESOLVED the Tohono O'odham Legislative Council authorizes the appropriation of monies in the amount of \$23,089.00 for salaries for the 4th quarter budget for the Tohono O'odham Nation Fire Department.

The foregoing Resolution was passed by the Tohono O'Odham Council on the 12TH. day of JULY, 1996 at a meeting at which a quorum was present with a vote 1,163.0 FOR; 134.0 AGAINST; -0- NOT VOTING; and 419.0 [10] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1 (d)(3) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


