WHEREAS, the Tohono O'odham Nation Legislative Council recognize the need to foster the development of educational programs designed to help its members; and

WHEREAS, the University of Arizona Cooperative Extension will provide technical assistance in the following areas: the Tohono O'odham Agricultural Extension Program in their demonstration and youth development programs; a development of a management and operational plan for the Livestock Complex Facility; a pilot 4-H youth development program; and livestock management; and

WHEREAS, the Tohono O'odham Legislative Council has reviewed and approved the FY 1996 Natural Resources Department proposal and budget; and

WHEREAS, the Natural Resources Department budget identifies \$960.00 for the Agreement with the University of Arizona; and

WHEREAS, the Agreement has been submitted for review and approval by the Natural Resources Committee.

12 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the

14 Tohono O'odham Nation's Officials, to wit: the Chairman and any
15 designated official are hereby authorized to negotiate and execute
16 the Agreement provided, however, that any amendments affecting
17 the funding or funding levels of the Agreement shall be submitted
18 for further prior approval by this Council.

22 The foregoing Resolution was passed by the Tohono O'Odham Council on the
23 12TH. day of JULY, 1996 at a meeting at which a quorum was present with a
24 vote 1,188.0 FOR; -0- AGAINST; -0- NOT VOTING; and 688.0 [12] ABSENT,
25 pursuant to the powers vested in the Council by Article VI, Section 1(d)2, (f) of
26 the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham
27 Nation on January 18, 1986; and approved by the Acting Deputy Assistant
28 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16
of the Act of June 18, 1934 (48 Stat. 984).




