4 **provision of Day Care Services for Parents who are employed and/or**
5 **in training; and**

7 **WHEREAS, the Tohono O'odham Nation has operated Day Care Services through**
8 **the Early Childhood Head Start Program for eligible parents of six**
9 **months (6) to three (3) and one half (1/2) year old children; and**

12 **WHEREAS, the Parent Fee Account is generated by parents utilizing Day Care**
13 **Services on the Tohono O'odham Nation.**

15 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham**
16 **Legislative fully supports the Day Care Parent Fee Budget in the**
17 **amount of \$38,856.05.**

20 **The foregoing Resolution was passed by the Tohono O'Odham Council on the**
21 **12TH. day of JULY, 1996 at a meeting at which a quorum was present with a**
22 **vote 1,397.0 FOR; -0- AGAINST; -0- NOT VOTING; and 479.0 [10] ABSENT,**
23 **pursuant to the powers vested in the Council by Article VI, Section 1(d)(3) of the**
24 **Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
25 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16**
27 **of the Act of June 18, 1934 (48 Stat. 984).**
