RESOLUTION NO. 96-307

WHEREAS, the Tohono O'odham Nation through its Department of Human Services seeks to apply for grants funds under the Notice of Fund Availability for Project Grants for Renovation or Construction of Non-Acute Health Care Facilities to use for repair and improvement of its health care facility located in Sells, Arizona, which is a rural health care facility which provides health care services to Tribal members and non-tribal members of the rural community located in Census tracking area of Pima County, Arizona, Census Number 0048, and for new construction of a building to house a dialysis center; and

WHEREAS, the grant amount available to fund a Rural Health Care facility is \$3.3 million; and

WHEREAS, the Department of Human Services seeking \$1,937,544 of that \$3.3 million; and

WHEREAS, the following project is recommended for submission to the Health Resources and services Administration:

- 1. Repair and Improvement of the Human Services Complex Facility on the Tohono O'odham Nation in Sells, Arizona, 85634.**
