

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Shopping Center Lease with Bank of America Arizona)**

RESOLUTION NO. 96-310

WHEREAS, the Commerce, Budget & Finance/Investment Committees have negotiated a lease with Bank of America Arizona under which a branch bank will be established in the Sells Shopping Center; and

WHEREAS, the branch bank will provide banking and financial services within the Tohono O'odham Nation for tribal members, businesses, governmental organizations and others now required to bear the expense and inconvenience of travelling to banking institutions outside the Nation; and

WHEREAS, the Commerce, Budget & Finance/Investment Committees recommend that the Legislative Council approve the lease.

NOW, THEREFORE, BE IT RESOLVED that:

- 1. The Tohono O'odham Legislative Council hereby approves the lease between Bank of America Arizona and the Tohono O'odham Nation, in the form attached hereto.**
- 2. The Chairman of the Nation is authorized and directed to execute the lease to the Bureau of Indian Affairs for approval.**
