contract shall be submitted for review and approval by the Tohono
O'odham Legislative Council; and**

**WHEREAS, Budget Modification No. 4 (attached) has been submitted for review
and approval by the Division of Child Welfare Services/Children's
Home Program.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
Council does hereby approve the amendment to the Divisions of Child
Welfare Services/Children's Home Program contract and authorizes
expenditures in accordance with the attached budget.**

**BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
that the Tohono O'odham Nation's Officials to wit: The Chairman,
Vice-Chairman and any designated official are hereby authorized to
negotiate and execute the contract, provided however, that any**

The foregoing Resolution was passed by the Tohono O'Odham Council on the 29TH day of JULY, 1996 at a meeting at which a quorum was present with a vote 1,226.0 FOR; -0- AGAINST; 231.0 NOT VOTING; and 419.0 [08] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2)(3), of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
