93-638 contract extension with the Bureau of Indian Affairs; and

WHEREAS, any amendments affecting the funding or funding levels of the
contract shall be submitted for review and approval by the Tohono
O'odham Legislative Council; and

WHEREAS, Budget Modification No. 3 (attached) has been submitted for review
and approval by the Division of Child Welfare Services/Children's
Home Program.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
Council does hereby approve the amendment to the Divisions of Child
Welfare Services/Children's Home Program contract and authorizes
expenditures in accordance with the attached budget.

12 Nation on January 18, 1986; and approved by the Acting Deputy Assistant
13 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16
of the Act of June 18, 1934 (48 Stat. 984).


