Senior Services/Adult Care Group Home Program under FY 1995 P.L.
93-638 contract extension with the Bureau of Indian Affairs; and**

**WHEREAS, any amendments affecting the funding or funding levels of the
contract shall be submitted for review and approval by the Tohono
O'odham Legislative Council; and**

**WHEREAS, Budget Modification No. 4 (attached) has been submitted for review
and approval by the Division of Senior Services/Adult Care Group
Home Program.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
Council does hereby approve the amendment to the Divisions of
Senior Services/Adult Care Group Home Program contract and
authorizes expenditures in accordance with the attached budget.**

**BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
that the Tohono O'odham Nation's Officials to wit: The Chairman,
Vice-Chairman and any designated official are hereby authorized to
negotiate and execute the contract, provided however, that any**

the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham
Nation on January 18, 1986; and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16
of the Act of June 18, 1934 (48 Stat. 984).


