**WHEREAS, during the July 9, 1996 General Session the Tohono O'odham
Legislative Council did pass Resolution No. 96-274, (Forgiving Debts
of the Districts of the Tohono O'odham Nation and Returning Funds
to District who have Repaid Debts); and**

**WHEREAS, upon presentation of Resolution No. 96-274 to the Chairman of the
Tohono O'odham Nation, he did disapprove thereof and returned
it to the Council with his objections in accordance with the
provisions of Article VII, Section 5 of the Constitution of the Tohono
O'odham Nation; and**

**WHEREAS, during the August 5, 1996 Legislative Session, the Chairman of the
Nation presented justification in vetoing Resolution No. 96-274; and**

**WHEREAS, the Legislative Council has reviewed the Chairman's objections and
after consideration again voted to pass Resolution No. 96-274.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
Council does hereby override the Chairman's veto by a vote of two-
thirds of the votes cast.**
