**WHEREAS, the Tohono O'odham Nation is presently operating the Community  
Health Representative/Community Health Services Divisions under FY  
1996 P.L. 93-638, Master Health Contract with the Indian Health  
Services; and**

**WHEREAS, the Tohono O'odham Nation has been notified by the Indian Health  
Services of an increase in the FY 1996 base allocation, the funding  
amount is increased to \$1,486,233; and**

**WHEREAS, any amendments affecting the funding or funding levels of the  
contract shall be submitted for review and approval by the Tohono  
O'odham Legislative Council; and**

**WHEREAS, a budget has been submitted for review and approval by the  
Community Health Representative/Community Health Services  
Divisions.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative  
Council that it does hereby approve and request Indian Health  
Services to modify the Master Health Contract No. 249-96-0001 to  
incorporate the attached budget.**

**19** Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
**20** 18, 1934 (48 Stat. 984).
