**WHEREAS, any amendments affecting the funding level of the grant with the Office of Human Development, Administration on Aging shall be submitted for review and approval by the Tohono O'odham Legislative Council; and**

**WHEREAS, an amendment has been submitted for review and approval by the Tohono O'odham Senior Services.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby approve the amendment and authorizes expenditures in accordance with the attached budget.**

**BE IT FURTHER RESOLVED that any amendments affecting the funding or funding levels of this grant shall be submitted for further approval by the Legislative Council.**


