

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 1997 Weatherization Assistance Program Proposal)**

RESOLUTION NO. 96-333

WHEREAS, request for proposal applications have been made available for tribal grants for FY 1997 through the Inter Tribal Council of Arizona, Weatherization Assistance Program; and

WHEREAS, the Weatherization Assistance Program is available to the Tohono O'odham Nation to assist O'odham members who meet the eligibility requirements; and

WHEREAS, it is in the best interest of the Tohono O'odham Nation to request for FY 1997 Weatherization Assistance Program funds; and

WHEREAS, the Tohono O'odham Nation Department of Human Services has submitted for review and approval a scope of work and budget that will conform to the eligibility criteria set forth in the funding and reporting regulations.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby authorize the officials of the Tohono O'odham Nation to submit a proposal for Weatherization Assistance funding from the Inter Tribal Council of Arizona and authorizes expenditures in accordance to the attached budget.

BE IT FURTHER RESOLVED that the duration of the grant shall be from the date of award through March 31, 1997.

BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation's Officials to wit: the Chairman, Vice-Chairman and any designated official are hereby authorized to negotiate and execute the grant, provided however, that any amendments affecting the funding or funding levels of the grant shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Council on the 7TH. day of AUGUST, 1996 at a meeting at which a quorum was present with a vote 1,876.0 FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(f), of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
