**(Acknowledging Resignation of Mary Jane Juan-Moore as Council Representative**  
**of Schuk Toak District)**

**LEGISLATIVE ORDER NO. 96-339**

**WHEREAS, Article XI, Section 1 & 3 of the Uniform Election Ordinance provides for procedures governing resignations for public officers of the Tohono O'odham Nation; and**

**WHEREAS, by letter dated August 5, 1996, Council Representative Mary Jane Juan-Moore did submit her resignation from office as Council Representative for the Schuk Toak District, effective August 5, 1996.**

**NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council does hereby acknowledge the resignation of Mary Jane Juan-Moore as Legislative Council Representative for the Schuk Toak District, effective August 5, 1996.**

**The foregoing Order was passed by the Tohono O'Odham Legislative Council on the 7TH day of AUGUST, 1996 at a meeting at which a quorum was present with a vote of 1,759.0 FOR; -0- AGAINST; 117.0 NOT VOTING; and (05) ABSENT, pursuant to the powers vested in the Council by Section 1(1) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


