RESOLUTION NO. 96-341

WHEREAS, the Southern Arizona Water Rights Settlement Act of 1982 (SAWRSA)
authorized certain agricultural developments to be designed and
constructed through the Bureau of Reclamation ("Reclamation"); and

WHEREAS, the Tohono O'odham Nation agreed to P.L. 93-638 Cooperative
Agreement (No. 3-FC-32-00200), Council Resolution No. 93-356) with
Reclamation to complete the predesign and design for the Schuk
Toak New Farm; and

WHEREAS, the Water Projects Office finds it must request a three (3) month
extension of time to the Cooperative Agreement in order to finalize
design documents, complete close out activities, and pursue
repayment costs which are the responsibility of the Secretary of
Interior under SAWRSA.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council
that it hereby approves an extension of Cooperative Agreement
3-FC-32-00200 until December 31, 1996 and authorizes expenditures
in accordance with the attached budget modification. There will
