**RESOLUTION NO. 96-343**

**WHEREAS, Resolution No. 95-407 approved the FY'96 Commerce Committee Budget as presented to the Tohono O'odham Legislative Council; and**

**WHEREAS, the Commerce Committee is proposing to modify the existing budget to establish a line item for Special Activities and transferring funds between line items; and**

**WHEREAS, the Commerce Committee and Budget & Finance Committee support the recommended changes.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council hereby approves Budget Modification No. 1 to the FY'96 Commerce Committee Budget as presented to the Tohono O'odham Legislative Council.**

**The foregoing Resolution was passed by the Tohono O'Odham Council on the 8TH. day of AUGUST, 1996 at a meeting at which a quorum was present with a vote 1,562.0 FOR; -0- AGAINST; -0- NOT VOTING; and 314.0 [06] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(3), of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


