**RESOLUTION NO. 96-351**

**WHEREAS, the Budget and Finance Committee of the Tohono O'odham  
Legislative Council reviewed the actual revenues for FY'96; and**


**WHEREAS, the revenue sources are adjusted to reflect changes from actual; and**

**WHEREAS, the Budget and Finance Committee is recommending the projected  
revenues for FY'97 in the amount of \$25,780,000.00.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative  
Council that the Projected Revenues and Funding Sources (attached),  
totalling \$25,780,000.00 are hereby approved for the purpose of  
funding the Tohono O'odham Nation's FY 1997 budget.**

**The foregoing Resolution was passed by the Tohono O'Odham Council on the  
9TH day of AUGUST, 1996 at a meeting at which a quorum was present with a  
vote 1,771.0 FOR; -0- AGAINST; -0- NOT VOTING; and 105.0 [02] ABSENT,  
pursuant to the powers vested in the Council by Article VI, Section 1 (d)(2) of the  
Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham  
Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16  
of the Act of June 18, 1934 (48 Stat. 984).**
