4 **WHEREAS,** the Legislative Council of the Tohono O'odham Nation approved of
5 funds (\$12,500) for the O'odham In Mexico School Children,
6 established as the O'odham In Mexico Scholarship Fund (account #01-
7 1503-625) administered by the O'odham In Mexico Program of the
8 Executive Department for FY'96; and

11 **WHEREAS,** the O'odham In Mexico Program has administered the funds jointly
12 with the National Indigenous Institute during August 1995 - June
13 1996 under an agreement which expired August 1, 1996; and

15 **WHEREAS,** the joint administration of the fund requires an agreement to
16 continue the distribution of funds; and

18 **WHEREAS,** the school year begins August 26, 1996 and payment for the first two
19 months was approved by the Executive Department and a new
20 agreement is needed in order to distribute these funds.

23 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative
24 Council that the Chairman of the Tohono O'odham Nation is hereby
25 authorized to enter into an agreement for the administration of the
26 O'odham In Mexico Scholarship Program Funds for the period August
27 and September 1996.

9 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to
Section 16 of the Act of June 18, 1934 (48 Stat. 984).




