**WHEREAS, the Budget and Finance Committee of the Legislative Council of the
Tohono O'odham Nation has reviewed this budget and recommends
it s approval and adoption.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
Council of the Tohono O'odham Nation that it approves the FY 1997
budget submitted by the Judicial Branch.**

18 of the Act of June 18, 1934 (48 Stat. 984).


