(FY 1997 Tribal Employment Rights Commission)**

RESOLUTION NO. 96-370

WHEREAS, the Tohono O'odham Nation created the Tribal Employment Rights Commission "TERO Commission" in 1982; and

WHEREAS, the funding for the Tohono O'odham Tribal Employment Rights Commission has been funded by the Tohono O'odham Nation; and

WHEREAS, the TERO Commission is essential to the operations of the Tribal Employment Rights Office; and

WHEREAS, the TERO Commission has been funded by the Tohono O'odham Nation on an annual basis; and

WHEREAS, the total budget amount is \$28,532.00 for the fiscal period of October 01, 1996 to September 30, 1997.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby approves the FY 1997 budget for the Tribal Employment Rights Commission.

BE IT FURTHER RESOLVED that the duration of the FY 1997 Budget shall commence on October 01, 1996 through September 30, 1997.

19 pursuant to the powers vested in the Council by Article VI, Section 1(d)(3), of the
20 Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham
21 Nation on January 18, 1986; and approved by the Acting Deputy Assistant
22 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16
23 of the Act of June 18, 1934 (48 Stat. 984).
