RESOLUTION NO. 96-374

**WHEREAS, the Tohono O'odham Nation Legislative Council approved the FY
1996 Natural Resources Budget with Council Resolution No. 96-145;**

and

**WHEREAS, any amendments affecting the funding or funding levels of the
budget shall be submitted for review and approval by the Tohono
O'odham Legislative Council; and**

**WHEREAS, the Tohono O'odham Nation Agricultural Extension Program requests
an amount of \$5,500.00 to allow for continued operation of their
program for the remainder of the fiscal year; and**

**WHEREAS, the Agricultural Extension Program is under the supervision of the
Natural Resources Department; and**

**WHEREAS, savings of \$22,855.00 has been identified in the Natural Resources
budget under Personnel Costs; and**

**WHEREAS, an amount of \$5,500.00 will be transferred to the Agricultural
Extension Program for fiscal year 1996 only; and**

**WHEREAS, the remaining savings of \$17,355.00 will be added to the Natural
Resources Program Costs line items; and**

WHEREAS, a modification has been submitted for review and approval by the Natural Resources Committee.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Nation Legislative Council hereby approves the Budget Modification No. 2, transferring \$5,500 from the Natural Resource budget to the Agricultural Extension Program budet for FY 1996; and the remaining savings added to the Natural Resources Department's Program Cost line items, and authorizes expenditures in accordance with the attached budget.

The foregoing Resolution was passed by the Tohono O'Odham Council on the 22ND. day of AUGUST, 1996 at a meeting at which a quorum was present with a vote 1,691.0 FOR; -0- AGAINST; 80.0 NOT VOTING; and 105.0 [04] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(3), of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
