5 **WHEREAS,** the Tohono O'odham Nation on an annual basis appropriates general
6 funds to programs and departments for operating expenses and
7 personnel costs; and

9 **WHEREAS,** general funds are also appropriated to subsidize the expense of
10 operating program for which contract and grant resources are
11 insufficient; and

14 **WHEREAS,** historically the Nation has provided funding to the Agriculture
15 Extension program, (the Program) as a subsidy to its contract
16 services, a program under the newly established Natural Resources
17 Department of the Nation; and

20 **WHEREAS,** the Program has experienced an increase in service delivery expense
21 which has placed the Program in need of additional funding to finish
22 out the current fiscal year; and

25 **WHEREAS,** initial start up funds were recently appropriated to the Natural
26 Resources Department in April of the current fiscal year; and

28 **WHEREAS,** savings were incurred from this appropriation primarily due to the

WHEREAS, savings were incurred from this appropriation primarily due to the length of time to formally establish the program and initiate purchases and expenditures; and

WHEREAS, the Executive Office has recommended that and approved the transfer of \$5,500 from the Natural Resources Department to the Agriculture Extension Program to assist the Program in the continuation of its operations for fiscal year 1996, for which Department and the Program have prepared budget modifications to effect this transfer; and

WHEREAS, the recommended transfer has been reviewed by the legislative oversight committees.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that the attached budget modification of the Natural Resources Department and the Agriculture Extension Program which transfer \$5,500 from the Department to the Program is hereby approved and authorized.

designated officials are hereby authorized to negotiate and execute
the contract, provided however, that any amendments affecting the
funding or funding levels of the contract shall be submitted for
further prior approval by this Council.

22ND. day of AUGUST, 1996 at a meeting at which a quorum was present with
a vote 1,771.0 FOR; -0- AGAINST; -0- NOT VOTING; and 105.0 [04] ABSENT,
pursuant to the powers vested in the Council by Article VI, Section 1(d)(2),(3) &
(f) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
O'Odham Nation on January 18, 1986; and approved by the Acting Deputy
Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to
Section 16 of the Act of June 18, 1934 (48 Stat. 984).
