4 **WHEREAS, Section I (a) of Article II of the Constitution of the Tohono**
5 **O'odham Nation provides that the Tohono O'odham Council can**
6 **make additions and changes to the official census rolls of the Sells**
7 **and Gila Bend Reservations dated January 1, 1937 and of the San**
8 **Xavier Reservation dated January 1, 1940, subject to the approval**
9 **of the Secretary of the Interior; and**

13 **WHEREAS, the Enrollment Committee has determined that the following**
14 **named person(s) was a member of the Tohono O'odham Nation on**
15 **the date of the respective census rolls but that their name(s) had**
16 **been inadvertently omitted therefrom, and had recommended that**
17 **their name(s) be added to the rolls; and**

21 **WHEREAS, the Tohono O'odham Council has reviewed the recommendations of**
22 **the Enrollment Committee and approves thereof.**

24 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that,**

12 with a vote of 1,738.0 FOR; -0- AGAINST; 138.0 NOT VOTING; and [01] ABSENT,
13 pursuant to the powers vested in the Council by Section 1(a) of Article II and
14 Section 1(h) of Article VI of the Constitution of the Tohono O'Odham Nation,
15 adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by
16 the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,
17 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
