WHEREAS, the Tohono O'odham Council has reviewed the recommendations of the Enrollment Committee and approves thereof.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that, subject to the approval of the Secretary of the Interior, the name(s) of the following person(s) be added to the official census rolls of the Sells, Gila Bend or San Xavier Reservation to wit:
