**(Suspending the Tohono O'odham Farming Authority Plan of Operation**  
**for 180 Days)**

**RESOLUTION NO. 96-387**

**WHEREAS, the Chairman of the Nation has provided the Legislative Council with certain information regarding the present Financial Management of the Nation's Farming Authority; and**

**WHEREAS, the Legislative Council does hereby find that this information requires immediate action to protect the Nation's assets.**

**NOW THEREFORE BE IT RESOLVED that the Tohono O'odham Legislative Council hereby suspends the Tohono O'odham Farming Authority Plan of Operations, for a period of one hundred eighty (180) days from this date.**

**BE IT FURTHER RESOLVED that the Chairman of the Nation is authorized to immediately take the following action:**

- 1. Secure and take control of any and all assets, including all bank accounts, property and financial records and documents now under the control of the Farming Authority.**
- 2. Conduct a fraud audit and report finding to the Legislative Council within sixty (60) days.**


