**RESOLUTION NO. 96-391**

**WHEREAS, the Human Resources Department has submitted to its Fiscal Year 1996 Tribal Budget a Budget Modification #1; and**

**WHEREAS, the budget modification reflect the difference in the salary amounts that are listed on the Fiscal Year 1996 budget and the actual amounts that are being paid, including a title change of (1) H.R. Analyst to an H.R. Technician; and**

**WHEREAS, adequate savings are in line item 610-Salaries to make corrections to the remaining Analyst salary, savings are derived from the above-mentioned title change and from vacant positions for part of the 1996 calendar year; and**

**WHEREAS, this budget modification reflect the moving of savings from line item 650-Training/Registration Fees to cover the projected program operational costs in line items 661-Travel/Mileage Allowance, 710-Utilities, and 771-Vehicle Repair/Maintenance for the remainder of Fiscal Year 1996.**

**NOW, THEREFORE BE IT RESOLVED by the Tohono O'odham Legislative Council that it does support, recognize and authorize the Human Resources**

21 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16  
22 of the Act of June 18, 1934 (48 Stat. 984).


