RESOLUTION NO. 96-403

WHEREAS, the Tohono O'odham Legislative Council is the Governing Body of the
Tohono O'odham Nation; and

WHEREAS, since 1989, the Tohono O'odham Nation has applied for HUD-CDBG
funding for community improvements in the areas of water and
wastewater systems, home repairs, roof repairs and replacement; and

WHEREAS, numerous presentations have been made to the Tohono O'odham
Legislative Council since the initial application; and

WHEREAS, the Legislative Council raised numerous questions on the delays of
the projects and impacts on future applications for projects and the
draw down; and

WHEREAS, the Legislative Council discussed other avenues to expedite the
projects i.e., sole source contracting with tribal contractors, and/or
allowing districts to be sub-recipients in the projects in their
respective areas.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council
that, in order to expedite the process, that the Districts be allowed,

projects in their respective Districts.

with a vote 878.5 FOR; 568.0 AGAINST; 429.5 NOT VOTING; and [03] ABSENT,
pursuant to the powers vested in the Council by Article VI, Section 1(f) & (l), of
the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
O'Odham Nation on January 18, 1986; and approved by the Acting Deputy
Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to
Section 16 of the Act of June 18, 1934 (48 Stat. 984).
