**RESOLUTION NO. 96-411**

**WHEREAS, the San Xavier District Council has reviewed the projected expenditures for Fiscal Year 1996/1997; and**

**WHEREAS, the San Xavier District Council did by Resolution No. SXDC 09-96-02, adopt the Fiscal Year 1996/1997 Budget in the amount of three million two hundred nine thousand three hundred seventy-nine dollars and sixty cents (\$3,209,379.60); and**

**WHEREAS, the Tohono O'odham Legislative Council has reviewed the San Xavier District's operating budget for Fiscal Year 1996/1997; and**

**WHEREAS, the Legislative Council has determined that the aforementioned budget is sufficient to meet the needs of the San Xavier District and its constituents; and**

**WHEREAS, the Legislative Council is aware that the San Xavier District Council has its own funds available in its treasury to meet the projected budget amount outlined in the attached Fiscal Year 1996/1997 budget.**

**NOW, THEREFORE, BE IT RESOLVED, by the Tohono O'odham Legislative Council that it hereby sanctions San Xavier District's Fiscal Year 1996/1997**

of the Act of June 18, 1934 (48 Stat. 984).
