WHEREAS, on September 9, 1996, the Budget and Finance Committee did review and approve the FY 1997 Legislative Budget and is recommending for approval by the Tohono O'Odham Legislative Council.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council hereby approves the FY 1997 Legislative Branch Budget in the amount of 1,354,992.00.

BE IT FURTHER RESOLVED that 1,354,992.00 be appropriated from the General Revenue Account.

The foregoing Resolution was passed by the Tohono O'Odham Council on the 10TH. day of SEPTEMBER, 1996 at a meeting at which a quorum was present with a vote 1,759.0 FOR; -0- AGAINST; -0- NOT VOTING; and 117.0 [06] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(3), of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
