**RESOLUTION NO. 96-416**

**WHEREAS, the Tohono O'odham Nation recognizes the need to obtain legislative  
and administrative advocacy services in regard to programs and  
services of the Federal Government of the United States of America;  
and**

**WHEREAS, the firm of Ducheneaux, Taylor & Associates has continued to  
provide adequate services into Fiscal Year 1996 including; to advise  
the Nation regarding Federal initiatives; to act as liaison with the  
Federal Executive and Legislative Branches; to arrange meetings  
with Federal Officials; to provide specific reports on services  
provided directly to the Nation; and**

**WHEREAS, funds in the amount of \$50,000 have been appropriated by the  
Legislative Council of the Tohono O'odham Nation for the purpose of  
obtaining these services in fiscal year 1997.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative  
Council that the Tohono O'odham Nation's Officials to wit: the  
Chairman or any designated official are hereby authorized to**

negotiate and execute the contract provided, however, that any amendments affecting the funding levels of the contract shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Council on the 11TH day of SEPTEMBER, 1996 at a meeting at which a quorum was present with a vote 1,732.0 FOR; 144.0 AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
