4 **WHEREAS, by Resolution No. 95-499, the Tohono O'odham Legislative Council**  
5 **approved a consultant contract with Graciela Barajas Robinson for**  
6 **consultant, interpretive and translating services to the Nation in the**  
7 **form of providing advice to the Cultural Preservation Committee**  
8 **("Committee") on issues affecting the Nation's interests in the**  
9 **Pinacate and Gran Desierto del Altar Biosphere Reserve in Sonora,**  
10 **Mexico and the Upper Gulf of California (hereinafter referred to as**  
11 **the "Pinacates") and the Nation's interests in the portion of the**  
12 **historic Papagueria within Mexico; attending meetings as directed by**  
13 **the Committee; researching and developing proposals to involve**  
14 **members of the Nation residing in Mexico in the management of**  
15 **resources in Mexico, providing training and environmental education**  
16 **for them, and developing funding proposals for such projects; and**  
17 **providing Spanish/English and English/Spanish translating and**  
18 **interpretive services; and**

**WHEREAS, the consultant contract for FY 96 was for \$35,000.00 consisting of \$30,000 for consultant services and \$5,000 for expenses; and**

**WHEREAS, the amount appropriated in the consultant contract was not sufficient in the expenses category for all of the activity in FY 96; and**

**WHEREAS, the Cultural Preservation Committee recommends to the Legislative Council approval of a consultant contract with Graciela Barajas Robinson for Fiscal Year 97 in the amount of \$40,000, representing an increase of \$5,000 in the expenses category over the FY 96 contract, for the services as outlined in the attached contract.**

**NOW, THEREFORE, BE IT RESOLVED THAT:**

- 1. The Tohono O'odham Legislative Council hereby approves a consultant contract with Graciela Barajas Robinson in the amount of \$40,000 for the fiscal year ending September 30, 1997, in the form attached hereto.**
- 2. The Legislative Council hereby appropriates the sum of \$40,000 from the General Revenue Account to pay the fees and expenses under the consultant contract.**

The Chairman of the Nation, the Chairman of the Legislative Council, and the Chairman of the Cultural Preservation Committee are authorized and directed to execute the consultant contract.

The foregoing Resolution was passed by the Tohono O'Odham Council on the 11TH day of SEPTEMBER, 1996 at a meeting at which a quorum was present with a vote 1,366.5 FOR; 438.5 AGAINST; 71.0 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) & (f), of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


