**WHEREAS, the Career Center students are providing services to the Baboquivari Indian Oasis Unified School District #40 from time to time; and**

**WHEREAS, for these services the Career Center students are compensated with an hourly wage; and**

**WHEREAS, a single check is made out to the Career Center totaling all monies earned for the service provided; and**

**WHEREAS, this check is to be deposited into the Career Center account # 01-1208-625 for dispersement to students who provided services; and**

**WHEREAS, this resolution has been submitted for review and approval.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby approves the distribution of funds from Baboquivari Indian Oasis Unified School District #40. Said funds shall be distributed to those students rendering services. To be effective 06/05/96.**
