4 **WHEREAS, the Tohono O'odham Legislative Council enacted the Uniform**
5 **Election Ordinance (Ordinance) of the Tohono O'odham Nation on**
6 **November 18, 1986; and**

8 **WHEREAS, pursuant to Article II, Section 1(B) of the Ordinance the Tohono**
9 **O'odham Legislative Council is empowered to appoint members of**
10 **the Election Board; and**

12 **WHEREAS, on July 19, 1994, the Legislative Council appointed Matilda Juan to**
13 **a term on the Election Board to end July 1995 pursuant to**
14 **Resolution No. 94-309; and**

17 **WHEREAS, the Council also appointed Jose Nick Lopez to a term on the Election**
18 **Board to end July 1996, pursuant to Resolution No. 94-309; and**

20 **WHEREAS, both terms have ended and no appointments have been made to the**
21 **Election Board; and**

23 **WHEREAS, the Rules Committee, the oversight committee of the Election Board,**
24 **recommends both Matilda Juan and Jose Nick Lopez be appointed for**
25 **five year terms on the Election Board, pursuant to Article II, Section**
26 **1(B) of the Ordinance.**

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council

that :

- 1. Matilda Juan is appointed to the Election Board for a term of five years to begin July 1995 and end on July 31, 2000.**
- 2. Jose Nick Lopez is appointed to the Election Board for a term of five years to begin July 1996 and end July 31, 2001.**

The foregoing Resolution was passed by the Tohono O'Odham Council on the 12TH day of SEPTEMBER, 1996 at a meeting at which a quorum was present with a vote 1,689.0 FOR; -0- AGAINST; -0- NOT VOTING; and 187.0 [05] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(b), of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
