4 **WHEREAS, there are no other attorneys to handle conflicts which the Nation's**  
5 **Advocate Program is not ethically allowed to handle in the increasing**  
6 **needs of tribal members for legal representation in civil and criminal**  
7 **matters; and**

10 **WHEREAS, the Advocate Program wishes to retain Patricia Overmeyer to be**  
11 **appointed to represent clients with conflicts of interest who can not**  
12 **be represented by the Nation's Advocate Program; and**

15 **WHEREAS, the Advocate Program wishes to retain Patricia Overmeyer as a**  
16 **Conflict Attorney for the twelve (12) months of FY-97, and projects**  
17 **the cost of such services at \$16,466.25; and**

19 **WHEREAS, the Advocate Program has presented a contract for Patricia**  
20 **Overmeyer which confirms and ratifies the terms and conditions**  
21 **related to future services, a copy of which is attached; and**

24 **WHEREAS, the Domestic Affairs Committee recommends approval by the**  
25 **Legislative Council of an Attorney Contract with Patricia Overmeyer**

**NOW, THEREFORE, BE IT RESOLVED THAT:**

1. The Legislative Council ratifies and approves the Conflict Attorney Contract for Patricia Overmeyer, in the form attached hereto, for the period of October 1, 1996 through September 30, 1997 in the amount not to exceed \$16,466.25.
2. Funding for the Conflict Attorney Contract for Patricia Overmeyer shall be provided under the operating budget of the Advocate Program for Fiscal Year 1997.

The foregoing Resolution was passed by the Tohono O'Odham Council on the 12TH day of SEPTEMBER, 1996 at a meeting at which a quorum was present with a vote 1,876.0 FOR; -0- AGAINST; -0- NOT VOTING; and [08] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 2(a), of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
