

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Gu-Vo District Ranger Budget for Fiscal Year 1997)**

RESOLUTION NO. 96-433

WHEREAS, the Gu-Vo District Council met on August 13, 1996 at which a quorum of nine District Council members were present; and

WHEREAS, the District Council did review the attached budget for the District's Ranger Program FY 97 Budget in the amount of Two Hundred Twenty Thousand, Nine Hundred and Six Dollars and Eighty-Eight cents; and

WHEREAS, the Gu Vo District Governing Council does support and approve the Gu-Vo District Ranger Program Budget of FY '97 in the amount of \$220,906.88

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and supports the Gu-Vo District Ranger Program with a full appropriation in the amount of \$220,906.88.

The foregoing Resolution was passed by the Tohono O'Odham Council on the 12TH. day of SEPTEMBER, 1996 at a meeting at which a quorum was present with a vote 1,215.0 FOR; -0- AGAINST; 501.0 NOT VOTING; and 160.0 [06] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(3), of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


